



Conditions of Entry: Admission to Events: COVID-19 Amendments

Bags Restrictions:

1. **All bags must be small enough to be able to fit under your seat.**
2. Due to current COVID-19 restrictions, cloakings is not currently offered at the MCG.

Personal:

1. By attending the MCG, you acknowledge that you have considered the health risks associated with your own personal circumstances, including any health condition or vulnerability that you may have, and the circumstances of persons with whom patrons will be in close contact following attending at the MCG.
2. You acknowledge that, some groups of people, such as people 70 years and older, people 65 years and older with one or more chronic medical conditions, people with compromised immune systems and Aboriginal and Torres Strait Islander people 50 years and older with one or more chronic medical conditions, are especially at risk of serious infection from COVID-19. By attending an event you (and any persons who attend the event with you) acknowledge and accept these obvious risks
3. The MCC strongly recommends that you install the Australian Government COVIDSafe App on your mobile device, with Bluetooth activated prior to entering our venue.
4. If you appear unwell and exhibit any symptoms of COVID-19, you will be refused entry or requested to leave the venue immediately.
5. Adhere to the following COVID Safe requirements:
 - a. Stay home if you are feeling unwell, currently have symptoms of COVID-19, have travelled overseas in the past 14 days, or have been in contact with a confirmed COVID-19 case in the past 14 days, or have undertaken a COVID-19 test recently with results pending.
 - b. Practise physical distancing
 - c. Wear a face mask in accordance with health authority requirements.
 - d. Follow signage, sit in the designated seating area on your ticket, and move around within your zone only to use the amenities including food and beverage outlets
 - e. Wash your hands or use a hand sanitiser regularly. You can bring your own, or you can use one of our hand sanitizing stations in the venue.
 - f. Cough or sneeze into your elbow and dispose of tissues responsibly
 - g. Practise physical distancing
 - h. Wash your hands with soap or use your own sanitiser regularly
 - i. Use the government QR code system to register your attendance when you enter the venue
6. Remain in your ticketed seat at all times unless:
 - a. You are moving to your seat as part of ingress
 - b. You are leaving your seat to egress the venue
 - c. You are moving to use the amenities within the venue (purchase food or drink, use the bathroom, attend first aid)
 - d. Dwelling in certain bars is permitted. Patrons are requested to register their attendance in the bar through the government QR system. Density restrictions apply to these areas.
 - e. Dwelling in standing room areas of the seating bowl is not permitted.

Failure to adhere to the above requirements may result in you being requested to leave the venue.

Venue:

- 1. The venue is operating as a 'cashless' venue during current COVID-19 restrictions. Please be advised that cash is not accepted throughout the MCG and precinct, this includes food and beverage and merchandise outlets.**
- 2. You must not approach any player, performer or match official, and must stay at least 1 seating rows (1.5 metres) away from the arena, interchange bench, player dug out or player / official arena-race at all times.**
- 3. The venue has been split into five zones for contact tracing purposes. You have been allocated a zone on your ticket. You must remain in that zone and not cross into any other zone.**
